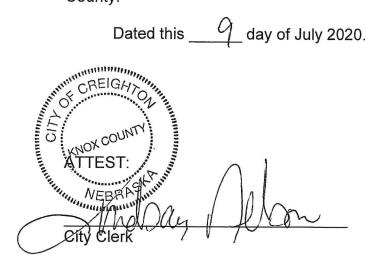

A regular meeting of the Mayor and Council of the City of Creighton, Nebraska was held in the meeting room of the Creighton City Offices at 809 Main Street in said City on the 10th day of December, 2020, at 6:30 p.m. Present were: Mayor Steve Mayor Morrill and Council Members Bob Jensen, Drew Nelson, Mark Ripp, Amber Ostronic, Samuel Davidson, Eric Schroeder; Administrator/Clerk/ Treasurer (ACT) Lindsay Nelson; Deputy Clerk Ronda York; Water Commissioner Kevin Sonnichsen; City Attorney Joe McNally; and Police Chief Mark Duncan.

Notice of the meeting was given in advance thereof by posting in at least three public places, as shown by the certificate of posting notice attached to these minutes. Mayor was given notice before the meeting. All proceedings hereafter shown were taken while the convened meeting was open to the attendance of the public.

McNally appointed new Councilman Eric Schroeder and Samuel Davidson. Schroeder and Davidson read their oath of office.

Jensen and Nelson stepped down for the council table at 6:38 p.m. At which time, Schroeder and Davidson took their spots at the table.

Mayor Morrill advised it was time to elect a City Council President. He asked for nominations. Schroeder nominated Ripp seconded by Davidson. There were no more nominations.

Schroeder made a motion seconded by Davidson to retain Ripp as Council President. RCV; All Ayes.

Mayor Morrill advised we would skip agenda item ten as it was a duplicate of item five.

Mayor Morrill advised boards had emailed their reports to Council. Four board reports given in person.

Mayor Morrill advised his 2021 appointments: Lindsay Nelson as City Administrator/Clerk/Treasurer; Joe McNally as City Attorney; Dr. Douglas Laflan as City Physician; Mark Duncan as City Police Chief; Midwest Bank as City Depository; Chris Miller of Miller & Associates as City Street Superintendent; and Chris Miller of Miller & Associates as City Engineer. A short discussion was held.

Schroeder made a motion, seconded by Davidson, to approve the Mayor's 2021 appointments as read. RCV; All Ayes.

Mayor Morrill read Resolution 2020-12 Signing of the Year-End Certification of the City Street Superintendent Form 2020 by title. Questions were asked and answered.

Ostronic made a motion, seconded by Schroeder, to approve Resolution 2020-12 Signing of the Year-End Certification of the City Street Superintendent Form 2020. RCV; All Ayes.

Mayor Morrill advised we will open the only sealed bids received for the City's Surplus patrol car. Mayor Morrill advised the bid was received from Wesley Eisenmann for \$550. Questions were asked and answered.

Davidson made a motion, seconded by Ostronic, to accept the bid for \$550 received from Wesley Eisenmann. RCV; All Ayes.

Mayor Morrill advised we will discuss the Tree Dump. ACT Nelson explained she has spoken with Richard Key. Questions were asked and answered. Mayor Morrill advised the Tree Dump will be added to Board Reports on future agendas to review their progress on cleanup. Mayor Morrill also added he will keep in touch with Mr. Key on the progress.

Mayor Morrill explained Leland Schlote has resigned from the Housing Authority. Jody Fuchtman, Housing Director, would like Dorothy Beaudette appointed. Questions were asked and answered.

Ripp made a motion seconded by Schroeder to approve the appointment of Dorothy Beaudette to the Housing Authority. RCV; All Ayes.

Mayor Morrill read invoices included in CDBG 15-DTR-106 drawdown #35 in the amount of \$8,354.39. Morrill advised this will be the last draw as all the money has been used. Questions were asked and answered. Morrill thanked the DTR committee for their work.

Chief Duncan gave a Creighton Police Report.

ACT Nelson gave an Administrator Report.

Council Member Ostronic gave a report.

Mayor Morrill gave a report.

All business complete, Ripp made a motion to adjourn, Schroeder seconded the motion. All present in favor.
