**MINUTES OF COUNCIL MEETING**  
**Thursday, February 10, 2022**

A regular meeting of the Mayor and Council of the City of Creighton, Nebraska was held in the meeting room of the Creighton City Offices at 809 Main Street in said City on the 10th day of February, at 6:30 p.m. Present were: Mayor Steve Morrill and Council Members Samuel Davidson, Mark Ripp , and Amber Ostronic, Eric Schroeder absent, Administrator/Clerk/ Treasurer (ACT) Lindsay Nelson, Deputy Clerk Ronda York, Water Commissioner Kevin Sonnichsen, Library Director Lisa Macke, and City Attorney Joe McNally.

Notice of the meeting was given in advance thereof by posting in at least three public places, as shown by the certificate of posting notice attached to these minutes. ACT Nelson gave an Administrator Report.


Council Members did not have a report.
